In accordance with Sections 263.152 through 263.157, inclusive, of Vernon's Texas Codes Annotated Local Government Code, the County of Morris, State of Texas, herby gives public notice of its intent to conduct a live auction to sell surplus consisting of the following: milled asphalt, sold by the yard in 200 yard lots.

All sales shall be finalized on an "as is, where is" basis and no warranties, either expressed or implied, shall be applicable to any property sold. The county reserves the right to withhold any item from sale and the Commisioners Court or its designated representative conducting the sale may reject any offer to purchase property if the Court or representative finds the rejection to be in the best interest of the County.

The auction will be held Tuesday, March 19, 2019 at the Morris County Courthouse, 500 Broadnax, Daingerfield, TX 75638, East door at 10:00 am. Inspections are by appointment only. For Questions contact the County Commissioner's Office at 903-645-3691, Todd Freeman, Precinct 4.

The auction will consist of approximately 1000 yards of milled asphalt product that has been stockpiled at the county for a long period and will be sold as surplus salvage material. Product will be sold in 200 yard increments at a minimum bid of \$25.00 per yard First Buyer to win auction of 200 yards will have the option to purchase an additional 200 yards up to the total 1000 at the bid price. Once the first buyer is done, another auction will begin for the next 200 yards until all tons are sold. Payment required day of auction payable to Morris County in the Treasurer's office, Suite E.

Buyers will be loaded out of main stockpile on a first come basis. Buyer's trucks and trailers must be able to haul a minimum of 6 yards in one load. County's bucket size is 1.1 yard which averages out to approximately 2050 lbs per yard.

If buyer opts to bring their own means of loading, buyer must coordinate with the county and get the county's permission to do so. County will have jurisdiction and first right of right of way, as there may not be enough room for 2 loaders to be loading out at the same time if buyer brings their own loader. County will measure/verify bucket size of buyer and will be on-site to observe/oversee loading. Buyer will provide the county with proof of commercial liability insurance before being able to bring loader on to county property. Contact the county to get more information regarding the minimum liability requirements. The county will not take any responsibility if truck leaves county property overloaded.

Seller cannot guarantee consistency of product, color, density, emulsion content, or other pertinent information to the material. The material being auctioned has different colors throughout the pile. There will be some chunks that will need to be broken, ground or screened. There are no guarantees; material is sold AS IS, WHERE IS.

County will load material with county backhoe, BY APPOINTMENT ONLY, on scheduled days. There will be NO after hours, weekends or county holiday loadout. County cannot guarantee that they can load any trucks or trailers that may be too tall for backhoe loader. County will not be responsible for any damages occurring.

Buyer will have up to 60 days after auction ends to remove material.
