I, or we, agree to furnish and deliver gasoline and diesel fuel to Morris County in calendar year 2026 in accordance with specifications outlined at the prices stated below.

1. E-10 blended gasoline - _____ cents per gallon above supplier's rack price in effect on date of delivery to county. No state or federal tax will be collected.
2. Off road low sulfur diesel only - _____ cents per gallon above supplier's rack price in effect on date of delivery to county. No state or federal tax will be collected.
3. On road low sulfur diesel - _____ cents per gallons above supplier's rack price in effect on date of delivery to county. No state or federal tax will be collected.
4. Rack prices plus Texas Product Delivery Fee from our supplier in effect on Monday, December 1, 2025 are:

Gasoline and Diesel Fuel Specifications

General Conditions

1. Morris County will accept bids from suppliers wishing to furnish gasoline and diesel fuel for the calendar year 2026. Bids must be submitted on BID FORM included in this package. Bids must be sealed, and the envelope clearly marked on the outside "Gasoline and Diesel Fuel Bid". Bids must be received in the County Judge's office, not later than 9:00 AM, December 8, 2025, at which time they will be publicly opened and read aloud. Morris County reserves the right to accept or reject any and all bids to protect the best interest of the county.
2. Bidder must furnish, with the BID FORM, a Letter of Commitment from (or copy of contract with) their bulk supplier which guarantees an uninterrupted supply of gasoline and diesel fuel sufficient to meet the projected needs of the county.
3. Gasoline and diesel fuel must be from a major refiner such as Chevron, Exxon, Texaco, Shell, Mobil, or equal quality refiner. This provision is in no way intended to limit competition but is intended to assure delivery of quality products for use by the county.
4. To allow for price fluctuations, bids will be based upon rack price charged to Bidder from their bulk supplier with a firm cent per gallon bid price above that rack price. The bidder shall furnish, in space provided on Bid Form, the rack price as of December 1, 2025, at 9:00 a.m. EXCLUDING TAX. The successful bidder will be required to furnish acceptable evidence to substantiate the rack price charge with each billing. Copies of bulk supplier invoices to Bidder or computer-generated market quotations will serve as acceptable evidence of rack price. Commissioners request that rack price be clearly stated on each delivery ticket issued (i.e., the request is for delivery ticket, not invoice).
5. Off road low sulfur diesel fuel shall be grade #2 or better.
6. Bidder may be required to furnish fuel tank at more than one location (approx. 3).
7. Bidder must guarantee delivery within 24 hours after the order is placed by telephone.
8. Bidders must apply for and secure exemption from federal tax on gasoline and diesel fuel to prevent the county from paying said federal tax.
9. Bidder must furnish monthly billing to the County Auditor's Office not later than the fifth (5th) day of the month covering all charges for the previous month.

10. Bidders may expect payment, for those charges invoiced as stated above, following each month's regular Commissioners' Court meeting scheduled for the second (2nd) and fourth (4th) Monday of each month.
11. Bidders may wish to consider the previous fiscal year's usage (Oct. 2024 – Sept. 2025) as follows:
 - A. Unleaded gasoline – approximately 17,091 gallons
 - B. Off road low sulfur diesel (dyed) – approximately 10,530 gallons
 - C. On road high sulfur diesel (clear) – approximately 3,524 gallons
12. Successful bidder will be awarded a contract through December 2026.

Motor Fuels Exemption

The Texas Legislature passed House Bill 1109 which amends the Texas Tax Code to exempt gasoline and diesel fuel sold to a county in Texas from the state motor fuels tax (currently 20 cents per gallon).

- **Effective Date: This exemption is effective beginning July 1, 2025.**
